The Ministry of the Environment together with the administrations of the national parks, the Faculty of Environmental Sciences, Czech University of Life Sciences Prague (CULS) and the Silva Tarouca Research Institute cordially invite you to the conference, focusing on conceptual issues associated with national parks in the Czech Republic.

The conference will be held at the CULS campus (Prague-Suchdol) Study and Information Centre on 21st - 22nd September, 2016.

The purpose of the conference is to present and discuss the current state and the future of national parks in the Czech Republic, including the international context. So far, four border national parks have been established in the Czech Republic, all of which are bilateral. What are their current status, challenges and goals? Is the current system of national parks sufficiently representative?

The partners of the conference are the EUROPARC Federation - Central and Eastern Europe Section, and the Nature Conservation Forum.

The conference is also held on the occasion of the 25th anniversary of the declaration of Podyjí NP and Sumaya NP and the redeclaration of the Krkonoše National Park.
